

Hillwood Estate, Museum and Gardens
Wedding Belles Bridal Sweepstakes Official Rules and Regulations

NO PURCHASE NECESSARY TO ENTER OR WIN.

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The Sweepstakes commences at 6:30 p.m. Eastern Time on June 15, 2011, and ends at 11:59 p.m. Eastern Time on October 1, 2011 (the "Promotion Period"). The Sweepstakes is sponsored by and prizes provided by Hillwood Estate, Museum and Gardens [Hillwood], 4155 Linnean Avenue, NW, Washington, DC, 20008

(1) Eligibility: The Sweepstakes is offered and open only to natural persons, age 18 and older as of the date of entry, who are legal residents of the United States of America for the duration of the Sweepstakes. An entrant's chance to win depends upon the total number of entrants. Employees, independent contractors, officers, and directors [vendors and legal advisors] of Hillwood Museum and Gardens, and the immediate family members and persons living in the same household of such persons, are not eligible to participate in the Sweepstakes. Void where prohibited by law. Offer not valid in Arizona, Florida, New York, or Rhode Island. At its discretion, Hillwood may ask for proof that award of any prize is permissible in the apparent winner's jurisdiction and if Hillwood, in its sole discretion, believe that the awarding of a prize may not be permissible, they may make the award to an alternate entrant chosen in the same manner who appears to be eligible.

(2) How to Enter: (1) In person: Complete and submit the Sweepstakes form, which is available at the Volunteer Desk in the Visitor Center lobby at Hillwood, 4155 Linnean Avenue, NW, Washington, DC 20008. (2) By Mail: Mail a 3.5" x 5" postcard on which are hand-printed the words "Wedding Belles Bridal Sweepstakes," and the entrant's name, age, address, telephone number, and e-mail address (if the entrant does not have an e-mail address, print "no e-mail address") to: Hillwood Estate, Museum and Gardens, 4155 Linnean Avenue, NW, Washington, DC 20008. Entries generated by a script, macro, or other automated means will be disqualified. No photocopied or mechanically reproduced entries accepted. (3) On-line: during specially-announced days on Hillwood's local business Facebook page. Each entrant may submit one (1) entry per person, household, or e-mail address. Hillwood is not responsible for late, lost, delayed, damaged, misdirected, incomplete, illegible, unintelligible, or postage-due entries. Incomplete, illegible, or corrupted entries are void and will not be accepted. To be eligible, in person entries must be received by 5 p.m. on October 1, 2011 and mailed entries must be received by 1 p.m. on October 4, 2011. All entries become property of Hillwood and will not be acknowledged or returned.

(3) Prizes: The winner will receive: \$1500 credit toward the purchase of a wedding gown from The Bridal Salon at Saks Jandel; one pair of designer shoes or credit toward from Neiman Marcus; credit toward wedding day make-up from Red Door Spa; silver wedding day jewelry from Tiffany & Co. Winner will be responsible for making all bridal gown purchases, fittings, and arrangements. No alternative prizes, cash equivalents, or other substitutions are permitted. All federal, state, and/or local taxes and other expenses associated with the acceptance and use of any prize are the sole responsibility of the winner.

(4) Winners: Hillwood will randomly select one potential Sweepstakes winner from all eligible entries received during the Promotion Period, on or around October 5, 2011. Winner will be notified by e-mail, or by telephone if winner does not have an e-mail address on or around October 5, 2011. All decisions by Hillwood in regard to this Sweepstakes are final and binding in all respects. Odds of winning depend on total number of entries received. In order to claim a prize, a winner may be required to complete an affidavit or declaration of eligibility and/or liability and publicity

release which must be signed and returned so that it is received within seven (7) days of date printed on notification or an alternate winner will be selected at random. If a selected winner is ineligible in any way, the entry will be disqualified and an alternate winner will be selected. If a selected winner is not of the age of majority in that winner's state of residence, the prize may be awarded to the winner's parent or legal guardian. Hillwood is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winners.
